Last week, Wendy, Sissi, Sofia and Eden attended a meeting with the Dean, Professor Simon Bronitt regarding student wellbeing. They noted that the Faculty was particularly keen on finding out more about student wellbeing and services accessed by students and would like a more student centric.

7 Disability Officer Proposal

A SULS member reached out regarding a proposal to introduce a Disability Officer to the appointed positions in SULS Executive. Wendy shared and discussed a proposal document and draft constitutional amendments prepared by the SULS member which was workshopped with





Wendy, Eden and Alison. Amendments to the proposal were suggested by various Executive members.

Felix suggested having a consultation session to allow members to voice their thoughts and concerns on the proposal. Georgia noted that we should be conscious of the timing of the meeting to ensure it is not around stressful assessment periods.

There was discussion about how to manage debate within the consultation forum due to the sensitive nature of the issues. It was noted that there are Zoom controls available to remove participants or moderate discussion if necessary. There was also discussion about the timing of the proposal, in particular, whether the amendments should be proposed at the Special General meeting. After some discussion, it was agreed that the changes warranted a General Meeting of their own to give time and space for adequate discussion and to ensure that members' voices could be heard.

Action items - Wendy and Alison will plan a timeline for the consultation period and meeting itself.

8 Headspace app

Sofia mentioned that Smiley Minds was an app that was suggested by Faculty at the meeting However, due to the features in the Headspace app, Headspace remains the preferred app for SULS to provide for its members. Sofia also noted that there was some feedback from students noting the usefulness of the Headspace app.

Nora asked if the apps were accessible only on mobile devices or if there was a web based application. Sofia will do more investigation.
